- 2. Keys policy/status. Lola reports that the cost for a thumbprint reader would be approximately \$2400 on 2 doors. The advantage is that changes can be entered locally. Proposal Don to go with the thumbprint reader dies for lack of support. Consensus to table the issue for more information.
- 3. The new 2017 IRS mileage rate is \$ 0.54.
- 4. The office will be closed on 11/15 for a safety day the opening of deer season.

ADMINISTRATIVE COMMITTEE - did not meet
