EXECUTIVE DIRECTORS REPORT

- 1. The office is still processing ticket refunds. Approximately \$148K has been returned, with some roll-overs and donations occurring. If no requests have been made by 12/1, it becomes an automatic roll-over.
- 2. Lola met with the Schafer family at the Song Stage. They were impressed and indicated that they will cover any necessary updates or improvements. The dedication will be rescheduled for Festival 2022. Thanks, Lola, for that kind gesture.
- 3. The October jamboree had 25 people. They may repeat in November, weather permitting, but then will be done until spring.
- 4. Budget forms have been sent out. Requests need to be submitted by 11/1 so the annual budget can be prepared for review at the November meeting.
- 5. Lola has been working on several grants, a couple are currently pending.
- 6. We recently had a bear visit the bins with the hand sanitizers...caught on our security camera.
- 7. Festival site is closed up, water turned off, etc. Winter office hours will go into effect after ticket refunds are complete. Monday & Friday, staff work remotely from home. Office open Tuesday through Thursday.
