EXECUTIVE DIRECTORS REPORT

- 3. Wheatscouts will be starting up again, with Veronica Stickler as the new coordinator. Proposal Carrie, second Chili, to Wheatscouts volunteers, as designated by Lola. Motion carried unanimously.
- 4. Robert Barnum will be doing a presentation at Big Rapids Art Works, with our sculpture, which will offer an opportunity for donations.

1. Fire Barn: Jim/Building Committee recommends that we implement plans for a pole barn type building to replace the tent that they have operated from for many years. Exact location yet to be determined, but in the general vicinity of its' usual location. Following discussion, it was determined that we need to follow policy to seek 3 bids on the project. We already have one bid. Details to follow. We will need to save as much of day parking as possible. A subcommittee of Jeff, Andy, Bob Beers & Don Baumann will look at location options. Proposal Chili, second Mary Ane, to allocate up to \$43,000 for the building, based on the numbers in the

- first bid. Motion carried unanimously. Lola notes that we may need to get approval through State Campground Licensing to add structures to our site plan.
- 2. Firehouse Subs grant: There are grant monies available through this organization. Wheatland Township Fire Department could benefit from this grant toward purchasing a transport cart, that could also be used at our events. Proposal Jeff, second Don, that we approve Eric Neumann to work with WFD on this grant, with WMO providing a letter of support and up to \$1000 in matching funds. Motion carried unanimously.
- 3. Proposal Carrie, second Andy, that Lola writer a Touring Arts grant to fund Jennifer Strauss storytelling programs through Community Education. Motion carried unanimously.
