Thanks to you, our donors and volunteers, Wheatland Music Organization continues to be a strong, well-managed organization that is successful in meeting its mission of preserving and presenting the traditional arts and serving as a regional resource center. Each year WMO serves over 30,000 people through Festival, Community Education programs in schools, pre-schools, libraries, senior sites, Music/Dance Lessons and Arts/Music Classes, Scholarships, Traditional Arts Weekend, Jamborees and Dances, Wheatscouts, Winter Wheat, Summer Wheat and other activities underwritten by WMO. Over the course of a year, over 1,000 volunteers contribute their time and talents to make sure quality arts is presented and that the property is well maintained. Volunteers hammer nails, plant trees, store picnic tables, serve on committees that plan year-round activities, work shifts during events and much more.

Each year we must raise over \$1,000,000 to pay for festival costs, year-round programming, provide resource center services and maintain our beautiful grounds and facilities. Together, we raise the dollars needed through ticket and merchandise sales, raffle, memberships and benefactor gifts, directed gifts (earmarked for an activity or item of your choice), building gifts (toward building and maintenance), and long term giving (for long term operations).
